

■ Request Hub – Rules & Workflow

Welcome to Request Hub!

This channel connects clients who need AI-generated content with our creators. Please read carefully how it works:

■ Workflow

Client submits a request via the official form.

The Admin posts the request in this channel.

Creators interested in the request send their censored previews/drafts privately to the Admin.

Important: Creators must always specify the Request ID when submitting their preview/draft. Submissions without ID will not be accepted.

Images/videos: low resolution, watermarks, or black blocks.

Audio: distorted or with beeps.

Text: partial or blurred content.

The Client reviews all previews and decides which proposal to move forward with.

The Admin informs the creators about the client's decision.

The Client pays the Admin securely only after the Admin has received the final uncensored file from the chosen creator.

The Admin keeps a 15% commission.

The rest is reserved for the chosen creator.

The Final file (uncensored) is delivered by the Admin to the Client.

The Creator is paid by the Admin after the Client's final approval.

■ Rules for Clients

No final work is delivered before payment.

Clients may request up to 3 revisions at the preview stage.

Beyond the 3rd revision, the Client must pay 10% of the project budget in advance for each additional preview revision.

Once the final work is approved, further modifications are possible at 10% of the budget per round.

Clients must provide approval or feedback within 48 hours of receiving a preview.

After 48 hours with no response, the work will be marked as "suspended".

Clear and detailed requests increase quality of results.

■ Rules for Creators

Send only censored previews or incomplete drafts until payment is confirmed.

Do not contact clients directly – all communication goes through the Admin.

Creators receive their payment within 48 hours after the Client's final approval.

Respect deadlines and deliver high-quality work.

Payments are guaranteed only for work delivered through the Admin.

■ Important

The Client chooses the creator.

The Admin acts only as intermediary for previews, payments, and deliveries.

Copyright & Ownership: After full payment, the Client obtains full rights of use for the delivered work.

Content Restrictions: It is forbidden to request or deliver illegal, offensive, or copyright-infringing content.

Confidentiality: All previews and final works are confidential and cannot be shared, reused, or resold outside the agreement.

Moderation: The Admin may refuse requests or exclude users (Clients or Creators) who do not respect these rules.

Payments: Processed via PayPal/Stripe/Bank Transfer (receipts available upon request).

Commission rate: 15%.

No bypass: Any direct deals outside this channel are not allowed.

By submitting a request, Clients accept this regulation.

By sending a preview, Creators accept the participation rules and the 15% commission.
